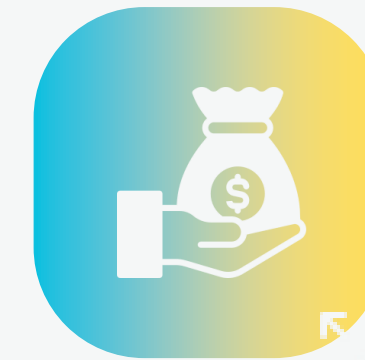
PROFIT SHARING
